

## Expression of Interest to be Nominated to the Lutheran Community Care Board of Directors



### Information to consider

#### Time Commitment:

Five Board meetings are held each year usually in February, March, May, September and November. Average meeting and preparation time is up to three hours. One meeting can be longer and include Board Development and Strategic Planning. During COVID travel restrictions, all Board meetings are by video conference. When travel is possible again, half of the meetings will be in person with Board members coming to Thunder Bay. The agency covers the travel and accommodation expense.

There are two standing committees of the Board – a Governance Committee and a Financial Audit Committee. A board member may be selected to serve on one of these committees.

The agency's Annual General Meeting is usually held in June and Board members are encouraged to attend.

#### Requirements of Board members:

- ✓ Able to contribute to the governance functions of the agency as it delivers a range of services including Developmental Services Ontario Northern Region, Passport (a direct funding program for adults with a developmental disability), case management and planning services for adults with a developmental disability, general social services, pastoral care services and street reach ministries.
- ✓ Agree to learn about and follow the Relationship Model of Governance™
- ✓ Agree to the agency's value statements
  - All people are equal.
  - People are to be treated with respect, care and compassion.
  - Individuals are entitled to receive choice-enhancing services that are holistic, empowering and culturally sensitive.
  - The services provided must be flexible, creative and responsive to individual and community needs.
  - We are accountable for the wise use of all entrusted resources.
  - Preventative services and proactive approaches are an effective use of resources.
  - Cooperative and collaborative approaches to service delivery are preferable.
